



Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.educom.world and Educational Communities Worldwide and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Educational Communities Worldwide include www.educom.world and EduCom.World. The EduCom.World website is an information site. By using the EduCom.World website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, EduCom.World may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

If you purchase EduCom.World's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties

EduCom.World does not sell, rent or lease its customer lists to third parties.

All such third parties are prohibited from using your personal information except to provide these services to EduCom.World, and they are required to maintain the confidentiality of your information.

EduCom.World may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on EduCom.World or the site; (b) protect and defend the rights or property of EduCom.World; and/or (c) act under exigent circumstances to protect the personal safety of users of EduCom.World, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by EduCom.World. Security of your Personal Information

EduCom.World secures your personal information from unauthorized access, use, or disclosure. EduCom.World uses the following methods for this purpose:

- SSL Protocol

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the





- achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
 - Comply with an existing legal obligation; or
 - Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

EduCom.World does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
